Emergency Shower and Eyewash Stations

Among the ANSI/ISEA Z358.1-2009 requirements for emergency shower and eye wash stations is that those stations be at the same level of the hazard, well-lit and identified with a sign. Many facilities make the mistake of following those requirements to the letter and disregard the intent. The primary objective is to make the stations clearly visible and easily accessible in the event of an emergency. More often than not they aren't. Signage and lighting make little difference if the area is visually and physically obstructed.


